K. S. Law No. 7 of 2023 Kano State of Nigeria

A Law to provide for Amendment of the Kano State & Local Government Revenue Administration (Consolidation and Codification) (Amendment No.1) Law, 2023 (1444 A.H) and for other matters connected therewith.

The Kano State House of Assembly ENACTED AS FOLLOWS:

- **1.** This Law may be cited as the Kano State & Local Citation and Government Revenue Administration (Consolidation & Commence-Codification) (Amendment No. 1) Law, 2023 (1444 A.H) and ment. shall come into force on the 22<sup>nd</sup> day of February 2023 (1444 A.H).
- **2.** The Kano State & Local Government Revenue Amendment Administration (Codification & Consolidation) Law 2021 of the (1443 A.H.) (here-in-after referred to as "the Principal Law") Principal is hereby amended in the manner herein provided.

Amendment of Section 2.

3. Section 2 of the Principal Law is amended by adding immediately after the definition of the word "State" the following new definitions:

means the governing board of Service: "Board" "Secretary" means the Director Legal Services and Secretary to the Service"

Amendment of Section 13.

- 4. Section 13 of the Principal Law is amended by adding immediately after the Section a new Section 13A which reads: "13A. (1)There shall be for the Service a director legal services who shall serve as the Secretary of the Service"
- (2) The Secretary shall be a qualified legal practitioner with at least 10 years post call experience.
- (3) The Secretary shall perform the following functions:
  - a. representing the service in courts;
  - b. advising the service and the Board on legal matters;
  - c. preparation of legal documents; and
  - d. serve as the Secretary to the Service and Board.
- (4) The Secretary shall be answerable to the Chairman of the Service.

Amendment of Section 18.

- 5. Section 18 of the Principal Law is amended by:
  - a. adding a subsection (1) immediately after the Section 18 to read Section 18(1); and
- b. adding a new subsection (2) immediately after subsection
- "(2) The Service shall have the power to deduct at source, from the revenue generated for the State and before remitting same to the State Consolidated Revenue Fund, such authorised sums of money to defray the cost of services rendered by consultants and other parties to the Service.
