- 1. KANO STATE STEERING COMMITTEE ON EXPORT PROMOTION
- 2. KANO STATE EXPORT STRATEGY AND GUIDELINES
- 3. FUNDING SOURCE OF THE COMMITTEE

Your Excellency may recall a series of activities coordinated and facilitated by KanInvest to align the State to meet up with the expectations of the State Action for Business Enabling Reform (SABER) program in line with the State Business Enabling Reform Action Plan (BERAP).

- 2. Relating to some of the key requirements of meeting the Disbursement Linked Indicators (DLI) on SABER program, DLI 6, requires the state to achieve the following:
 - Set-up and operationalise a State Committee on Export Promotion, with membership from key ministries.
 - 2. Design and launch the Kano State Export Strategy and Guidelines (annex I abc).
 - Identify funding source/operational budget, and fund the Committee to commence operation.
- 3. Accordingly, a key task given to our Technical Consultant on the SABER program was to develop an initial export strategy that will serve as the foundation for setting up of the State Steering Committee on Exports, as well as serve as a guide to exporters and businessmen intending to venture into export businesses in Kano.
- 4. The State Steering Committee on Exports is expected to have membership of the following personalities/offices:
 - Commissioner for Investment, Commerce, Industries, Cooperatives and Solid Minerals.
 - Commissioner for Budget & Economic Planning.
 - Commissioner for Agriculture.
 - Commissioner for Transport.
 - Director-General, Kano State Investment Promotion Agency (KanInvest).
 - Manufacturers Association of Nigeria (MAN) Representative.
 - Kano Chamber of Commerce Representative.
- 5. The Committee is also expected to undertake the following roles:

- Regular capacity-building programmes on costing and export pricing.
- Tailor-made assistance to exporters (office, online media, etc.)
- Provide top-down export market information (international commodity price).
- Provide bottom-up export market information (local commodity market report).
- Provide end-market information such as Tariffs and Import regulations to exporters to aid export pricing.
- Your Excellency may wish to note that KanInvest has a budgetary provision in the 2024 Approved budget that can be utilised for the operationalisation of the Committee to undertake the necessary export promotion activities and engagements. Accordingly, the below line item can be utilised for that purpose:
