SCHEDULE OF TRADE RELATED FEES AND LEVIES ON INTER-STATE MOVEMENT OF GOODS

In order to ease the suffering of our teaming taxpayers as well as the foreign investors in the state Kano State Internal Revenue Service hereby outline the official fees and procedures of the following revenue items:

- 1. **CONTAINER HAULAGE DISCHARGE FEE 12020455:** these fees are payable by consignees per each container at the point of discharge depending on the size of the container as follows:
 - i. 40ft size N10,000 per container
 - ii. 20ft size N5,000 per container
- SIGNAGE AND MOBILE ADVERTISEMENT 12020436: Jointly collected by State & Local Government based on the institutional structure established by the service N3,000
- 3. **SPECIALISED PARKING PARMIT 1400000000:** This permit is payable by operators of vehicles parking on the State roads at the rate of:
